**Heggies Pizza Sales Report**

**Concession Stand Report**

- Our supplies were removed from our boxes. Requested Gleason's cover cost of purchasing need materials. Will not be leaving materials there anymore.
- Talk about how to better distribute costs for bulk items.

**Board Changes:**

- T & T: still vacant ....*Coach Dave is leaving which means the T&T team may be over after this year so no need to actively get a new rep for this team at this time.*
- Outgoing members ...*Cassie and Amy leaving need to get a new Vice President and Secretary for the Executive Board of the Gypsy Booster Club*

**Website Updates:**

- Update board members....*Evelina will email Lisa at the Gleason's office to update the website with the board member changes.*

**Other Items:**

- Resi Mat: out of budget currently...*the RESI mats are around \$2600 - \$2700 to purchase and then \$400 to ship. The current GF does not have the funds. Need a way to continue to raise money for the GF throughout the year to make this large purchase.*
- General Fund: established and will possibly grow over time...*discussed the possibility of doing a "Mock Meet: at the gym that all proceeds would go to the GF. We could sell concessions and charge admission fees. We would have to hire judges which can be costly but we could do a couple of these a year and promote it even to class parents that by attending you will be giving money to the GF fund. Also discussed selling chocolate bars all year round but you have to buy the bars first and hope that you sell them. Also discussed leaving up the Heggie Pizza Payment box in the hallway and using it as a way for parents to donate to the GF and update them on items needed for the gym. Have to find a way to reach non team parents who want to help the gym in general maybe not a particular gymnast.*

- NPO volunteering: has been successful in my experience with SAVE. Spoke with a couple parents and there seems to be interest. I will write up an email and send it out to parents as other forms of fundraising. The NPO's will cover costs for tuition and have a check made out to Gleason's on your behalf....*NPO is a program where you donate your time and work events for other nonprofit organizations. NPO will pay you hourly and tips and then either send a check to the Gleason's directly for tuition, send it to the Booster Club to be applied to your gymnast account, or donate it to another nonprofit you want to support. Evelina has had success with this program. The startup fees are about \$20 for shirts and online training fees but those come out of your first pay check. Evelina will send an email out to parents about this program and how to sign up.*
